



UPDATE ON OUR PARISH RENTAL BUILDING

My beloved parishioners. You would recall that about three Sundays ago I informed you that Keeton, the people renting our property, are terminating their rent. I want to keep you informed about what is going on in that regard. No doubt, this is going to be a big change in the life of our parish because they have been our tenants for as long as many of our parishioners have been here. It is in the neighborhood of forty years.

First, it is important to acknowledge that we do not have any issues with them. Their leaving has nothing to do with landlord/tenant relationship. In fact, in fairness to them I want to say that they have been great tenants in the last one and half years that I have been here, and those who were here before me attest to that. It is undeniable how our parish has been blessed and enriched with their presence during the years that they have been here. However, we are not fully informed about their reason for closing the facility.

We understand that the inmates of the facility have been taken into other homes, and Keeton workers are fast moving their wares to their other locations. The information we got from their official notification to us was that they would vacate our property on the 31st of October.

The Parish Pastoral Council and the Finance Council are working together in following up with the developments. Through our attorney, we have written back to Keeton, asking that we both honor the terms of our lease agreement with them which states that they have to give us three months' notice before terminating their tenancy. We also asked for a convenient time for them to grant us access to walk through the building with them before they vacate it.

When we have fully sorted out all these uncertainties surrounding their departure, we will of course face the need to rent out the building to new tenants. For a building that has been rented by one organization for about forty years, it can only be imagined how much work we will need to do on it in order to be able to attract prospective renters.

The financial implication of this change happening in the middle of the fiscal year is enormous. Rent from the building accounts for a huge part of our parish budget. Please pray and work with me as we earnestly ask for alternative sources of meeting our budgetary obligations during this time. God does not abandon his people. He is always our helper in time of need. Blessings.
